TYPES OF ROOM RENTAL AND DEFINITIONS

- **INCIDENTAL ROOM RENTAL**. Rental or leasing of rooms within a single-family residence, provided all of the following are met:
 - All rooms offered for rent are within, and share a main building entrance with, the landowner's primary residence.
 - No more than two (2) bedrooms are offered for rent.
 - One off-street parking space is provided for each rental room.
- Transient or tourist. A person who travels to a location away from his or her permanent or legal address for a short period of time, not to exceed twenty-nine (29) days, for vacation, pleasure, recreation, culture, business or employment.
- **TRANSIENT OR TOURIST LODGING**. A residence that rents more than two (2), but not more than eight (8), bedrooms to transient guests or tourists, where all of the following apply:
 - o Rooms are rented to no more than twenty (20) individuals who are not members of the landowner's family.
 - Length of stay does not exceed twenty-nine (29) consecutive days for each registered guest.
- Transient or tourist lodging houses may include, but are not limited to: bed and breakfasts, hostels, and recreational cabins.
- **INDOOR COMMERCIAL LODGING**. A building or premises that provides lodging to transient or tourist guests, that meets at least one of the following criteria:
 - o Provides more than eight (8) rooms available for transient guests.
 - o Provides accommodations for more than twenty (20) transient or tourist guests at a time
- Indoor commercial lodging may include, but is not limited to: hotels, motels, inns or resorts.

SPECIFIC REGULATIONS BY ZONING DISTRICT

RESIDENTIAL DISTRICTS

SFR-08, SFR-1, SFR-2, TFR-08, MFR-08, RR-1, RR-2, RR-4, RR-8, RR-16, RM-8, RM-16

- Incidental room rental is a permitted use.
- Transient or tourist lodging may be approved with a conditional use permit in all residential districts, except in the MFR-08 district, where it is a permitted use.
- Indoor commercial lodging is prohibited.

FARMLAND PRESERVATION AND AGRICULTURE TRANSITION DISTRICTS FP-35, FP-B, AT-35, AT-B, AT-5

- Incidental room rental is permitted if associated with a permitted residence.
- Transient or tourist lodging may be approved with a conditional use permit in AT-5, and is prohibited in all other farmland preservation and agriculture transition districts.
- Indoor commercial lodging is prohibited.

HAMLET DISTRICTS HAM-R, HAM-M

- Incidental room rental is a permitted use.
- Transient or tourist lodging is prohibited in HAM-R and is permitted in HAM-M.
- Indoor commercial lodging is prohibited in HAM-R and may be approved with a conditional use permit in HAM-M.

- Indoor commercial lodging may be approved with a conditional use permit.
